Job opening - documentary competition for the teaching staff-career of the Polytechnic higher education in the category of Coordinator Professor in the technical-scientific area of Orthoptics

1. By the provisions of articles 10.^o, 10.^o-A, 15.^o, 15.^o-A, 19.^o and 29.^o-B in the Career Statutes of Teaching Staff in Higher Polytechnic Education (ECPDESP), approved by Decree-Law No. 185/81, of July 1st, amended by Decree-Law No. 207/2009, of August 31st and by Law No. 7/2010, of May 13th, under the terms and conditions of the Regulation of a Public Procedure for Recruitment of Career Teaching-Staff of the Polytechnic Institute of Porto, Dispatch No. 4807/2011, published in *Diário da República*, 2nd series, No. 54, of March 17th, and by the applicable legislation and norms, it is hereby made public that, by Dispatch of the President of the School of Health of Polytechnic Institute of Porto (ESS|P.PORTO), of 17 march 2021, in the use of own competence, by the provision of paragraph d) of No.1 of article 15 of School of Health Statutes, according to Dispatch No. 2832/2018, published in *Diário da República*, 2nd series, No. 55, of March 19th, a documentary job competition is opened for a period of thirty working days, starting from the date of the publication of this notice in *Diário da República*, to occupy a planned and unoccupied job position on the staff map of the School of Health of Polytechnic Institute of Porto (ESS|P.PORTO), in the career of teaching staff in higher polytechnic education, in the category of Coordinator Professor, Orthoptics technical-scientific area, according to the contract of work in public functions of indefinite duration.
2. Workplace – ESS|P.PORTO, Rua Dr. António Bernardino de Almeida, 400, 4200-072, Porto.
3. Number of available positions – 1 (one).
4. Form of employment contract – Employment contract in public functions for indefinite duration, pursuant to article 10 of Decree-Law No. 185/81, of July 1st, amended by Decree-Law No. 207/2009, of August 31st and by Law No. 7/2010, of May 13th, which approved the Career Statutes for Teaching Staff in Higher Polytechnic Education (ECPDESP).
5. Category functional content - The coordinator professor is responsible for developing the functions described in No. 5 of article 3 of the ECPDESP.
6. Admission's Scope - Cumulative requirements for admission to the competition:
 - a) The fulfillment of the requirements set forth in paragraphs b) to e) of No. 1 of article 17 of the General Labor Law in Public Functions (LTFP), approved by Law No. 35/2014, of June 20th, with the subsequent amendments;
 - b) Hold a doctoral degree or specialist title, under the terms of Decree-Law No. 206/2009, of August 31st, in the specific area or related areas for which this competition is open, obtained at least 5 years,

according to article 19 of the ECPDESP. For the purposes of this competition, related areas are those in which the doctoral thesis of the candidate represents a relevant contribution in the area for which the competition is open;

- c) The opponents of the competition holding a foreign qualification must prove its recognition, equivalence or registration of the doctoral degree, in accordance with the applicable legislation;
- d) The fulfillment of the requirements contained in the Career Statutes of Teaching Staff in Higher Polytechnic Education, in its current wording, and those contained in the Regulation of Procedure for Recruitment of Career Teaching-Staff of P.PORTO, approved by Dispatch No. 4807/2011, published in *Diário da República*, 2nd series, No. 54, of March 17th, 2011.

7. Job competition validity:

7.1 The competition is valid for the aforementioned job position, expiring with its occupation or absence or lack of candidates.

7.2 The job competition may also be terminated by a duly motivated act of the IPP President, respecting the general principles of administrative activity, as well as legal, regulatory and bidding limits.

8. Application formalization:

8.1 Entries are submitted electronically via the website:

8.2 The following must be submitted with the application:

- a) Electronic application form for the tender procedure;
- b) A copy of the curriculum vitae, organized according to the selection and ranking criteria described in number 9 of this Notice;
- c) Evidence and/or copies of each element mentioned in the curriculum vitae, organized according to the selection and ranking criteria described in number 9 of this Notice;
- d) Documents proving that the applicant meets the requirements referred to in paragraph b) of No. 6 of this Notice;
- e) Copy of identity card/ citizen card.

8.3 Without prejudice to the provisions of point vii) of paragraph j) of article 13 of the Regulation for Competitions for Hiring Teaching Career Staff at the Polytechnic Institute of Porto (RCCPCD), the non-presentation by the candidate of probative documents related to the curriculum vitae, as well as the non-organization of the curriculum vitae in accordance with the provisions of paragraph b) of nº 8.2, determine the non-appreciation of these curricular elements.

8.4 Candidates working at ESS | P.PORTO are exempt from submitting documents that already exist in its individual files (it is considered the responsibility of the candidate to confirm which documents are contained in its individual file), and the fact must be expressly stated in the request form.

8.5 All the submitted documents must be in Portuguese or English or exceptionally in another foreign language, and the Jury may, by deliberation, require their translation.

8.6 Applications sent by email are not accepted.

8.7 Without prejudice to the obligation to send the elements stipulated in the previous numbers, the Jury may ask applicants, exceptionally, to provide additional documentation related to the submitted curriculum.

8.8 The exception referred to in point 8.7 does not replace the provisions of points 8.1, 8.2 and 8.3, with the sole purpose to clarify any doubts raised by the Jury.

9. Candidate selection and ranking criteria:

The selection and ranking criteria and respective weighting are based on the general functions of teachers, as provided for in Article 2-A of ECPDESP.

9.1 The approval of candidates on absolute merit will depend on whether they hold a doctoral degree or a specialist title, under the terms of Decree-Law No. 206/2009, of August 31st, in the area or related areas for which the this competition is open, obtained at least five years, according to article 19 of the ECPDESP, and for the purposes of this competition, related areas are considered those in which the doctoral thesis of the candidate represents a relevant contribution in the area for which the competition is open; and have a curriculum whose merit the jury considers to have a scientific and pedagogical level, research capacity and developed activity compatible with the disciplinary area and category for which the competition is open.

9.2 It is considered approved on absolute merit the candidate who is approved by an absolute majority of the voting jury members, in which the vote must be favorable whenever the jury member has assigned a score equal to or greater than 50, based on the details of the selection and ranking criteria.

9.3 Candidates approved on absolute merit will be ranked based on the scores obtained according to the details of the selection and ranking criteria.

9.4 The dimensions of the selection and ranking criteria are as follows:

- a) Pedagogical Dimension – 35%
- b) Technical-Scientific and Professional Dimension – 35%
- c) Organizational Dimension (other activities relevant to the institution's mission) – 30%

9.5 Pedagogical Dimension Parameters (35%):

9.5.1 Experience and dedication to teaching in the area where the competition is open and duration of activities (60%):

Relevant experience for the area for which the competition was opened as a full time/exclusively teacher in higher education; Conducting different Curricular Units in the area for which the competition was opened, in Higher Education; Teaching Curricular Units in the area for which the competition was opened, in Higher Education.

9.5.2 Production of teaching material and extension activities and pedagogical innovation (40%):

Didactic-pedagogical documents or digital materials that cover all or part of the contents of a course to support the learning of Orthoptics; Author or co-author of texts to support learning with ISBN in the area for which the competition is open; Participation in jury of access and entry in Higher Education in the area for which the competition is open; Participation as a student in pedagogical or technical-professional updating courses; Participation in mobility programs; Other pedagogical activities relevant to the Higher Education Institution.

9.6 Parameters of the Technical-Scientific and Professional Dimension (35%)

9.6.1 Academic/Professional Qualification (35%):

Enabling access: Doctoral degree with thesis theme relevant to the area for which the competition is opened or Specialist Title in Orthoptics (Decree-Law No. 206/2009, of 31/08); Degree in Orthoptics; Master with dissertation theme relevant to the area for which the competition is opened; Other degrees and/or masters, or aggregation, or equivalent; Professional certificate in the field of diagnosis and therapeutics – Orthoptist.

9.6.2 Scientific Production (30%):

Author or co-author of scientific articles in a journal that integrates one of the Web of Science Core Collection indexes – Clarivate Analytics and that has an Impact Factor; Author or co-author of scientific articles in other peer reviewed journals, books and/or chapters of technical-scientific books and chapters in conference proceedings; Author or co-author of abstracts in conference proceedings or abstracts published in an indexed or peer-reviewed journal.

9.6.3 Dynamization and intervention in scientific activities (20%):

Participation in funded researched projects and/or obtaining research grants; Integrated member of FCT accredited R&D center or other recognized entity; Member of scientific committees of national or international technical-scientific events; Trainer in a short scientific or technical course, not integrated into study cycle conferring a degree; Author or co-author of oral or poster communication, at a national or international congress, academic or professional; Author or co-author of works that have received a Scientific Award.

9.6.4 Scientific orientation and participation in academic and professional exams juries (15%)

Orientation or coorientation of completed doctoral theses; Orientation or coorientation of dissertation/project/ masters internship final report completed; Orientation or coorientation of degree projects completed; Participation in jury of academic doctoral exams; Participation in jury of masters academic exams; Participation in jury of degree exams; Participation in jury of specialist title exams.

9.7 Parameters of the Organizational Dimension (30%)

9.7.1 Top and middle management in statutory organic structures in higher education (75%):

Rector or Vice-Rector/ President or Vice-President/ Director or Sub-Director of a Higher Education Institution, including Faculty, Organic Unit and/or School; President or Vice-President of the Technical-

Scientific Council or the Pedagogical Council; Member of top statutory organic structures in higher education; Coordinator/director of department/technical-scientific area; Study cycle coordinator in higher education.

9.7.2 Participation in institutional commissions, competitions and event organization (15%):

Member of juries for recruiting teaching staff under the statutes of higher education teaching careers; Participation in internal or external institutional committees in a higher education institution, derived from statutory bodies; Member of the organizing committee of congresses, seminars or other technical-scientific and pedagogical events; Other organizational activities relevant to the higher education institution.

9.7.3 Participation in community activities, interinstitutional cooperation and service provision (10%):

Participation in organizing/planning community activities; Participation in community activities and provision of services abroad.

9.8 The Jury may hold public hearings, under equal circumstances for all candidates, in accordance with the provisions of paragraph b) of No. 4 of article 23 of the ECPDESP.

10. The final grade given individually by each Jury member will be obtained by the following formula: $NFEJ = 0,35 \cdot AP + 0,35 \cdot ATCP + 0,30 \cdot AO$, where NFEJ corresponds to the final grade of the element of the Jury; AP = sum of the scores attributed to the candidate in the component related to the pedagogical activity; ATCP = sum of the scores attributed to the candidate in the component related to the technical-scientific and professional activity; AO = sum of the scores attributed to the candidate in the component related to the organizational activity.
11. In accordance with No. 3 of article 20 of Regulation for Recruitment of Career Teaching-Staff of the Polytechnic Institute of Porto, teachers in management positions in their organizational units/ institute and exempt from teaching functions by virtue of the application of legal or statutory regulations or by determination of the competent bodies shall not be harmed in the application of the grid to the parameter referred to in point 9.5 of this Notice.
12. Interested participation and decision:
 - 12.1 The draft final ordination shall be notified to the candidates, for the purposes of the hearing of interested parts, in accordance with articles 121 and following of the Code of Administrative Procedure, applying, with appropriate adaptations, the provisions of article 25 of the Regulation.
 - 12.2 After the hearing of the interested parts, the Jury appreciates the allegations offered and approves the final ranking list of the candidates.

12.3 Prior Hearing – In the event that any of the candidates is excluded for not complying with the legal requirements and at the end of the assessment made, the prior hearing will be held in accordance with the provisions of articles 121 and 122 of Administrative Procedure Code.
