Calculation formula for assigning the final grade:

Final classification = (Pedagogical activity * 0.35) + (Technical-scientific activity * 0.35) + (Organizational activity * 0.30)

In the event of a tie, the following tiebreaker criteria are used successively:

1. Have seniority as a teacher or equivalent to a full-time or invited teacher or exclusivity in Higher Education, in the area for which the public tender is open;
2. Having completed a doctoral degree or specialist title the earliest.
